### **FWCP medical Commission**

To be declared fit to practice sport parachuting, the candidate to the license and to the diploma of sport parachuting must meet the following conditions:

1. Minimum age: 16 year old in the within the year.
2. Have a good general constitution but it is not necessary to have a specially developed musculature. Tendency to being overweighed will be appreciated according to the functional repercussion it brings.
3. Have a normal abdominal musculation. Hernia, weakness an lesions to the abdominal lining in contra-indication with the effort of a parachute jump are eliminatory. The last important surgical operation in relation with the abdominal lining will go back to at least 3 months.
4. Interventions on the big vessel and on the arterial circulation of lower limbs constitute in principle a contra-indication.
5. Have the functional integrity of the respiratory system, it cannot show a clinical sign of tuberculosis. Every cases of asthma and emphysema must be subjected to a study of the respiratory function.
6. Grave digestive affections who may cause a sudden risk of inaptitude are let to the judgment of the examining doctor.
7. Any antecedent of traumatism or lesion of the brain or the brainpan will be subjected to a deeper neurology examination. An EEG is let to the judgment of the examining doctor.
8. Have a mental and emotional equilibrium compatible with the learning and the execution of parachute jump. Will be eliminated: the subjects showing an exaggerate emotivity, a neuropathic condition, emotional problem or abnormalities to the personality.
9. Any antecedent of cardio-vascular disease must be subjected to a deeper examination.
10. Any candidate 50 years old or more will pass during the year an electrocardiogram.
11. Be free from affections of the spinal column, pelvis and upper and lower limbs, susceptible of causing un obstacle to safety of a jump in normal conditions.
12. Have a visual acuteness minimum of 1/10 on one eye and 2/10 on the other before correction with the condition that global vision may reach the unit with corrective glasses. Have a sufficient color and deepness perception.
13. Have a satisfactory hearing and a good tubular permeability.
14. Be free from chronical intoxication (drugs or other).
15. For all female candidate, pregnancy is a contra-indication.
16. In case of doubt or litigation on the candidate's aptitude to the sport parachuting. The examining doctor or the candidate may ask the opinion of the national commission.
