

GENRAL MEETING 2016 REPORT DD 14/03/2017 AT THE LAST REFUEL at SPA AIRFIELD.

Meeting starts at : 07.40 pm

President's Speech : Several events were organized that never met a huge success for reasons that were not determined.

The number of sport jumps has significantly increased. Very good results encountered for the Safety aspect. This situation results of the excellent job done all along the season by both Jonathan Delges and André Vanhaudenard.

Significant increase of the number of Club Tandem jumps which brings an important contribution to the financial situation.

Report on Activities 2016:

- 338 members (325 inn 2015). The increasing rate is the same as last year.
- A total of 18.352 jumps for 16.547 jumps in 2015. (+ 12 %)
- 9.400 Fun jumps. (usually around 7.500) in which 1.053 free jumps (more than 10 % of free jumps !!).
- 3.244 Club Tandem jumps. This brought the financiation for the free jumps. The President insists on the fact that thoses free jumps are not to be granted automatically. They will be given in relation with the (financial) results of the year.
- 464 AFF Student jumps, 71 CSC jumps and 23 jumps for the Canopy Piloting school (values to be confirmed).
- Grand total of 25.093 jumps including those of Skydiving Promotion against a little bit more of 23.000 jumps in 2015

Incidents report

- 8 occurrences of different types. Reserve rides : 4 students, 7 experienced skydivers and 6 Tandems.
- The President takes benefit of this opportunity to explain, one more time, what the SMS is. He also develops the circumstances of the incident that happened with a visisting helicopter.

Treasurer's Report :

- Profit for the 2016 year : 18.294.12 €. This amount could be , at a later stage, be distributed to the Members in the form of Free jumps.
- Cumulated Profit : 85.000 € +

Balance acceptation and discharge to the Administrators for 2016 :

- The auditors (Vanessa Sauer & Morgane Dethier) confirm their agreement.

Nomination of new Auditors for 2017 : Jean-François Caby and Vanessa Sauer.

<u>New member of the Board :</u> André Vanhaudenaerd is accepted without one dissitent voice.

Projects for 2017 :

- Easter Monday Eggs dropping and Open Door .
- CITA DES AILES. Will take place July 7th with a possibility for Balloon Jumps from our own Balloon by the evening.
- Teams support : A full support to Jet Max and and some help to the Aeropotams.
- Roaster Booggie at Cerfontaine June 23rd to 25th. Load Organizers wanted !!
- Canopy Piloting to be organized this Summer.

<u> Misc :</u>

A deal has been concluded with the FS Teams to give some coaching or FS camps. It will not be possible to organize the "Jour le Plus Long" due to the Exploitation Permit of the Airfield.
