1. Public Liability (PL)

a. **B**odily Injury Liability 2.500.000€

b. Third Party Property Damages 250.000€ -for damages excessing 125€

c. **M**aster **T**andem **L**iability 75.000€ (*Tandem Passenger*)

2. Individual Accident Insurance (IAI) - for injuries excessing 125€

a. Death 7.500€
 b. Permanent Invalidity 15.000€
 c. Medical Care 2.500€
 d. Repatriation¹ 2.500€

Additional Individual Accident Insurance (AIAI)²

a. **D**eath 25.000€

b. Permanent Invalidity 25.000€ - for invalidity level exceeding 10%

c. Temporary Invalidity 12.50€/day – after 30 days and for maximum 365 days

d. **M**edical **C**are 3.100€ (*Maximum 3x INAMI*)

<u>Insurances are valid in the whole World except in the following countries or regions:</u>

- Algeria, Burundi, Cameroun (extreme North), Center African Republic, Congo Democratic Republic, Ethiopia, Kenya, Mali, Mauritania, Nigeria,
 Somalie, Soudan Republic and South Soudan.
- Colombia and Peru.
- Afghanistan, Jammu et Cashmere, North Korea, Pakistan.
- Abkhazia, Donetsk and Lugansk Ukrainian Regions: Nagorno Karabakh, North Caucasian Federal District, South Ossetia.
- Iran, Iraq, Lebanon, Libya, North Sinaï Egyptian Province (Including Taba International Airport), Syria, North and South Yemen.
- Each and every country where the aircraft operations would take place in violation with sanctions issued by the United Nations.

Remarks:

- NEW: Flights in Wind Tunnels are covered.
- Payments will take place only against presentation of justificative documents and after the payments of your legal Medical Care Insurance³.

 Justificative documents must be forwarded to Group Assur.
- The Additional Individual Accident Insurance (optional against additional costs) must be specially requested and is only provided as an addition to the Basic Individual Accident Insurance.
- Should repatriation be needed, you have to organize it and you will be refunded up to the covered amount and only against presentation of
 justificative documents.
- Insurance renewal formalities for the following year can take place from December 1st.

If you want to go abroad and plan to make parachute jumps

- Contact your Mutual Insurance Company to obtain the necessary documents in case of illness or accident in a foreign country.
